This workshop will be a combination of presentation (rules, regulations, Q&A) and hands on introduction for working spot teams. Handlers will learn the basics about each class. Working spot dogs will be introduced to all 4 classes (Urban Locating, Trailing & Locating, Shed Dog, and Lost Item Recovery. Handlers may work different dogs in each class but may not work more than one dog in each class without an additional entry. Handlers wanting to work with more than 1 dog in all classes must register each dog separately, full price for working spot #1 and then 1/2 price for additional working spots, limit 3 dogs per handler.
