

## **Group Class Info Sheet**

Group classes provide the perfect environment for learning new behaviors and proofing established behavior. Your dog will have a chance to learn, and practice, self-control even in the presence of other dogs and people and help develop your dog's social skills. Group classes help you learn to work with your dog to keep their attention in a new place and with distractions.

Classes will be at 1220 Weil Street, Suite #4, Billings, MT. Classes will be kept small to ensure quality training.

Reminder: **Only feed your dog half of his meal prior to class session.**

### **RULES FOR GROUP CLASS**

- Keep your dog on leash at all time.
- If dogs do sniff each other, allow max 3 seconds and then redirect with voice before leash gets tight.
- When walking in and out of class keep distance.
- Please don't wear sandals, flip flops or other type of footwear, you can easily slip out of.
- Be respectful of your dog and other teams in the class. No harsh corrections allowed.
- Make sure to have lots of fun. Park ego outside :)

### **WHAT TO BRING**

- 3 different types of treats. Ex.: kibble, small soft and stinky training treats, boiled chicken or hotdogs cut into small pea-sized pieces. Lots of them. Remember, your dog will learn to work through distractions and be rewarded for doing so, so make ensure your treats are more valuable and interesting that the surroundings.
- Bully stick, stuffed Kong toy or good natural chew bone. No rawhides. No Nylon bones. This is something for your dog to chew on during talks and breaks, thus encouraging him to settle.
- Only flat buckle collar or harness allowed on dog in class. No exception!
- A 6 ft leash. No retractable leashes allowed.
- Mat/towel/dog bed. Something the dog can settle on. This will be very helpful for you, when going places with your dog, and he already has learned a nice settle behavior on the mat.
- This Group Class Agreement (see page 2-4) filled out plus a copy of updated vaccination record.
- Payment, preferably cash or check.

## TERMS & CONDITIONS

Blue Creek Canine, LLC, hereinafter known as “the Company” cannot make any guarantee regarding the outcome of any training/counseling program. The owner assumes full responsibility for the dog’s behavior during and after the training/counseling program. \_\_\_\_\_ *Owner Initial*

### LIABILITY

I, \_\_\_\_\_ as the legal owner/agent of the above mentioned pet(s), having carefully read and fully understand this agreement, do hereby waive and release the Company, its owner, directors, trainers, employees and representatives, and their dog(s) \_\_\_\_\_ from any and all liability of any nature. This includes any injury, death, sickness or damage my pet may suffer during or after any training program. I also agree to indemnify and hold harmless the Company, its owner, directors, trainers, employees and representatives, and their dog(s) from any and all claims due to damage the pet may cause to any family members of any third parties during or after training. The owner specifically acknowledges that they recognize the risk of taking a group class with other people and their dogs. This risk is entered into with the owner 100% responsible for their dog’s behavior at all times in the class environment.

### VACCINATION

I hereby certify that my dog(s), that I enter in the class(es) , will have **been started** on a course of vaccines or have received a **full** course of vaccines recommended for their age OR **I can show results from titer tests confirming antibodies**, by the time of the **1<sup>st</sup> class session that dogs attend**.

I further certify that my dog(s) have been checked for, and are free from, any worm infestations before being brought to class. **Any dogs showing any signs of infections/virus or worms will immediately be excused from class until seen by a qualified veterinarian and confirmed healthy with a written notice.**

Bring updated list of current vaccinations given to your dog(s) signed by your veterinarian, or titer results, otherwise dog is not allowed in class.

### TERMINATION OF TRAINING

The owner of the dog(s) may have the animal withdrawn from training at any time, however, once training has begun; all fees are non-refundable, but will be credited towards any other class as long as participation in a new class is within 12 months.

### MISCELLANEOUS

The owner/agent will be responsible for purchasing all necessary equipment that the trainer recommends for training the dog(s).

In the event either party deems it necessary to employ legal counsel to protect its rights under this agreement, the prevailing party agrees to pay all expenses including, but not limited to costs and reasonable attorney’s fees.

This training agreement and Addendum A represents the full and only agreement between the parties. The terms and conditions set forth in this agreement cannot be modified or changed in any way unless agreed to by both parties in writing. I have read, fully understand and agree to the above contract terms.
